- Dawn was asked to follow up on what other inclusive opportunities they are getting at this time.

7:09 MTSS Tier 1-3 (RBT) Equal Access to Students with Disabilities

- "A public entity may not deny a qualified individual with a disability the opportunity to participate in services, programs, or activities that are not separate or different, despite the existence of permissibly separate or different programs or activities." CFR 35.130(b)(2)
- Mystie reports that this issue was mitigated nicely by the district.
- Background: A presentation was given to the Board recently about the MTSS tier 1-3
 that was available to the district. When a special education teacher went to utilize
 these multi-tiered systems, they were denied and referred to special education since
 it had to do with a child in special education. Red flags arose that there may be a
 violation.
 - Mystie brought it to the attention of Dr. Thompkins and Tricia Thompson and they were proactive on the issue. They put together clarification in writing, shared it with CAC, and distributed it to all the principals and the school sites. Special education kids have full access to MTSS tiers just like general education students. They will also be sharing this verbally in a principal's meeting.
 - Prior to the consideration of the MTSS Tier 3 RBT support, It was discussed with Trica the following alternative Tiered support should be exhausted:
 - 1. Tier 1
 - ➤ PBIS strategies character education (This is a whole class instruction delivered by a school psychologist or counselor)

2. Tier 2

- > STEPS program (This is a small group program at the elementary school level)
- > Small group counseling (this is more for the upper grades)
- ➤ Requesting a non-SpEd specific Functional Behavioral Assessment also referred to as an FBA to determine the function of the behavior (This training is currently being delivered to all the school psychologists) coupled with a Behavioral Intervention Plan also known as a BIP. These referrals can be made to the school psychologist or to the TSA (Teacher on Special Assignment) specific to the MTSS site support.
